

AN ORDINANCE OF THE TOWN COUNCIL OF THE TOWN OF ENNIS,
MONTANA PROVIDING FOR THE AMENDING OF CERTAIN SECTION
OF THE EXISTING CODE TITLE 14.08 LION'S PARK.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF ENNIS:

Section 1

14.08.020 Penalties and Fines.

Fines for any citation issued for the illegal fishing in the Lion's Park Pond will be \$100.00 for the first offense, maximum of \$300.00 and \$100.00 for each subsequent offense; Plus a \$20.00 surcharge.

Section 2

Ordinances Repealed

All Ordinances or parts of Ordinances in conflict with the provisions of this Ordinance are hereby repealed. These are Ordinance No. 119, section 14.08.020 entitled "Fines for any citation issued for the illegal fishing in the Lion's Park Pond", finally passed on July 13, 1995.

Section 3

Severability

If any provision of this ordinance is declared unconstitutional, or the applicability thereof to any person or circumstances is held invalid, the constitutionality of the remainder of the ordinance and the applicability thereof to other persons and circumstances shall not be affected thereby.

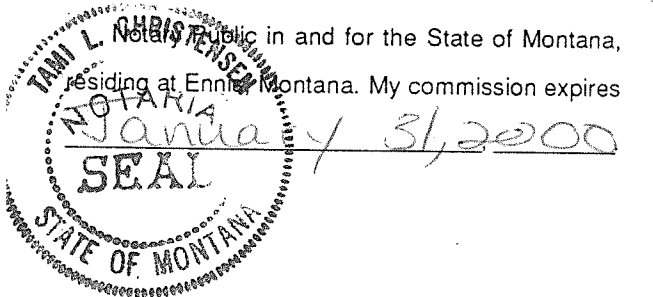
