

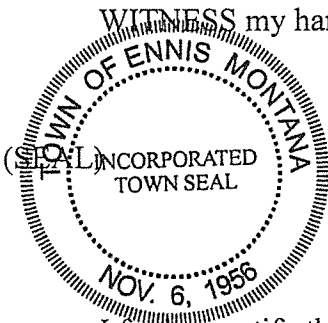

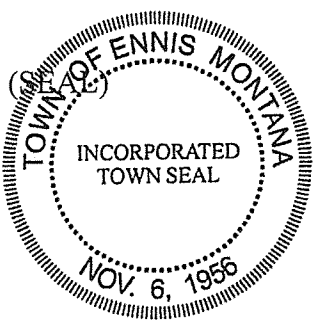

ORDINANCE NO. 138

ORDINANCE OF THE TOWN OF ENNIS, MONTANA
CREATING A STREET MAINTENANCE DISTRICT;
PROVIDING A METHOD OF PERFORMING THE
MAINTENANCE AND A METHOD OF ASSESSING FOR THE
COSTS OF THE MAINTENANCE

WHEREAS, the streets in the Town of Ennis, Montana (the “Town”) are in need of significant maintenance work to keep the streets from deteriorating beyond repair; and

WHEREAS, the Town, in consultation with Great West Engineering, Inc. (the “Engineer”), has developed a five-year plan of maintenance for the streets of the Town; and

WHEREAS, the Town desires to create a street maintenance district and to assess the properties within such district to defray the costs and expenses related to the maintenance of the Town’s streets; and

WHEREAS, the Town Commission (the “Commission”) of the Town is authorized by Title 7, Chapter 12, Parts 41, 42 and 44, Montana Code Annotated, as amended (the “Act”), to create street maintenance districts as provided in the Act.

NOW, THEREFORE, BE IT ORDAINED by the Commission of the Town as follows:

Section 1. Proposed Maintenance; Intention To Create District. The Town proposes to provide for certain local street maintenance to specially benefit all property located in the Town. The boundaries of the proposed street maintenance district (the “District”) are coterminous with the Town limits, as shown on Exhibit A. The Commission intends to create and establish the District under the Act for the purpose of paying for the costs of maintaining the streets in the District and the creation and administration of the District.

Section 2. Number of District. The District shall be known and designated as Street Maintenance District No. 01 of the Town of Ennis, Montana.

Section 3. Boundaries of District . The current limits and boundaries of the District are depicted on a map attached as Exhibit A hereto (which is hereby incorporated herein and made a part hereof), which boundaries are designated and confirmed as the boundaries of the District. A listing of each of the properties in the District, the owners thereof, and the estimated amount of the initial annual assessment against each lot, tract or parcel are shown on Exhibit B hereto (which is hereby incorporated herein and made a part hereof). Properties in the District that are exempt from real property taxes will not be subject to assessment for the costs of the maintenance. It is the Commission’s intent that the boundaries of the District will be coterminous with the Town’s limits, as such limits may change in the future, and such change or changes to the boundaries of the District will be implemented in accordance with the Act.

Section 4. Benefited Property. The District and territory included within the limits and boundaries described in Section 3 and as shown on Exhibit A and described on Exhibit B are hereby declared to be the street maintenance district and the territory which be benefited by the

maintenance to be performed. The properties to be assessed for a portion of the costs of the maintenance are listed on Exhibit B; provided, however, that properties in the District that are exempt from real property taxes will not be subject to assessment. The properties included within said limits and boundaries are hereby declared to be the property benefited by the maintenance program.

Section 5. General Character of the Maintenance. The proposed maintenance includes chip sealing, patching and crack sealing of the asphalt surface, asphalt overlays and other general maintenance for street integrity for the streets included in the District, as further provided in the Town's 5-year street maintenance plan, attached as Exhibit C.

Section 6. Estimated Cost. The Town, in consultation with the Engineer, has estimated the cost of the maintenance for the first five years, as shown on the attached Exhibit C. Prior to the end of the fifth year of the maintenance plan, the Town will adopt a new multi-year maintenance plan by ordinance for the District and the Town may amend the 5-year maintenance plan from time to time. Dollar amounts, dates of maintenance undertakings, inflation amounts and other figures set forth on the attached Exhibit C are estimates only and may change due to a variety of factors. Amounts assessed will be used to pay current maintenance costs for ongoing maintenance and to accumulate over time to an amount adequate to pay for major repairs and replacements. The Town will make a good faith effort to follow the said maintenance plan, as described in Exhibit C, subject to the capped assessment dollar amounts that are expressly stated in Section 7.1 herein below.

Section 7. Assessment Methods.

7.1. Methods; Property To Be Assessed. Each lot, tract, or parcel of land with a dwelling or commercial building located on it in the District, other than lots, tracts or parcels that are exempt from real property taxes will be assessed up to \$75 annually. Each vacant lot, tract or parcel of land in the District, other than lots, tracts or parcels that are exempt from real property taxes, will be assessed up to capped dollar amount of \$35 annually. Actual assessments will be determined by the Town Commission annually by resolution based on the actual costs of the maintenance to be performed; however, all said annual assessments within the district shall not exceed \$75 and \$35 respectively, as stated herein. The determination of the Town Commission not to assess properties in the District for maintenance in any year or years will not affect the validity or existence of the District.

7.2. Assessment Methodology Equitable and Consistent with Benefit. This Commission hereby determines that the method of assessment and the assessment of costs of the specific maintenance against the properties benefited thereby as prescribed in Section 7.1 are equitable and in proportion to and not exceeding the special benefits derived from the respective maintenance by the lots, tracts and parcels to be assessed therefor within the District.

Section 8. Public Hearing; Protests. At any time within seventeen (17) days from and after the date of the first publication of the notice of the introduction of this ordinance, any owner of real property within the District subject to assessment and only those subject to assessment for the cost and expense of the maintenance may make and file with the Town Clerk's office until 5:00 p.m., M.T., on the expiration date of the 17-day period (December 8, 2014), written protest against the proposed maintenance, or against the creation of the District or both. Such protest

must be in writing, identify the property in the District owned by the protestor and be signed by all owners of the property. The protest must be delivered to the Town Clerk's office, who shall endorse thereon the date of its receipt by the Town Clerk/Treasurer. This Commission will at its next regular meeting after the expiration of the seventeen (17) days in which such protests in writing can be made and filed, proceed to hear all such protests so made and filed; which regular meeting was held on December 11 2014, at 7:00 p.m., in the Commission Chambers, at 328 W. Main Street, in Ennis, Montana and with an additional special meeting to be held on December 18, 2014, at 5:45 p.m., in the said Commission Chambers.

Section 9. Notice of Introduction of Ordinance. The Town Clerk/Treasurer is hereby authorized and directed to publish or cause to be published a copy of a notice of the introduction of this ordinance in *The Madisonian*, a newspaper of general circulation in the Town, on November 19 and November 26, 2014, in the form and manner prescribed by law, and to mail or cause to be mailed a copy of said notice to every person, firm, corporation, or the agent of such person, firm, or corporation having real property within the District listed in his or her name upon the last completed assessment roll for state, Town, and school district taxes, which property is not exempt from real property taxes and will be subject to assessment, at his or her last-known address, on or before the same day such notice is first published.

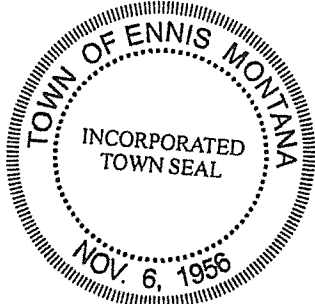
Section 10. Creation of the District; Insufficiency of Protests. Prior to adoption of this ordinance on second reading, and following the conclusion of the protest period described in Section 8, above, if the Commission determines that the Town Clerk/Treasurer did not receive written protest by: (1) owners of property subject to assessment within the proposed maintenance district having a taxable valuation, when aggregated, representing not less than 50% of the total taxable valuation of property within the District; (2) not less than 50% of the owners of property subject to assessment within the District; or (3) owners of property subject to assessment within the proposed maintenance district having projected assessments, when aggregated, representing not less than 50% of the total projected assessments for property within the District, then this Commission, immediately prior to the second reading of this Ordinance, will adopt a resolution creating the District, which shall be attached to and form a part of this Ordinance as if set forth in full herein.

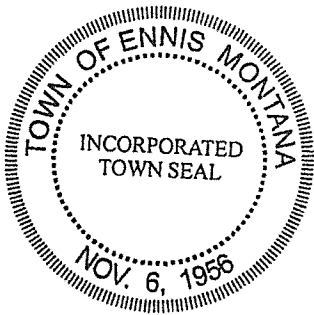

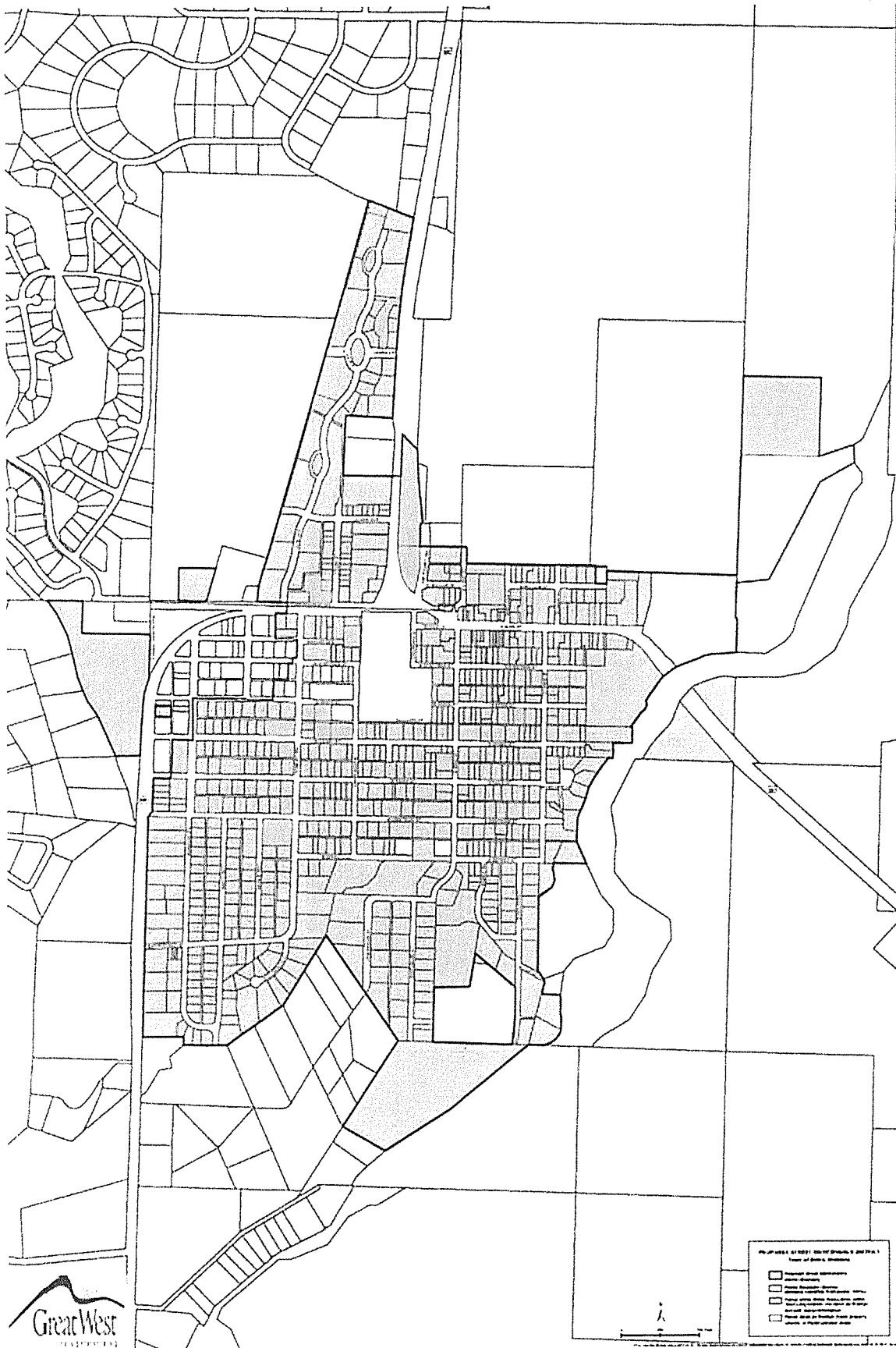
