

AN ORDINANCE PROHIBITING ENTRANCE INTO AN INTERSECTION WITH FACING STOP SIGN WITHOUT A COMPLETE STOP, EXCEPT WHEN DIRECTED BY A TRAFFIC CONTROL OFFICER OR LIGHT; DESIGNATING STOP STREETS WITHIN THE TOWN OF ENNIS, PROHIBITING ENTRANCE INTO SIDEWALK AREAS AND ROADWAYS WITHOUT STOPPING AND YIELDING RIGHT OF WAY AND PROVIDING FOR PUNISHMENT IN CASE OF VIOLATION THEREOF

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF ENNIS:

Section 1. That it shall hereafter be unlawful and a violation of this ordinance for any individual driving a motor vehicle within the Town of Ennis to enter into any intersection upon which a stop sign is erected facing the individual, without coming to a complete stop before entering the intersection, except when directed to proceed by a police officer or highway patrolman or traffic control light.

Section 2. That there are hereafter designated as "stop" streets at which "stop" sign shall be erected, those streets hereinafter named when they intersect the streets named immediately thereafter.

First Street intersecting Main Street  
 Second Street intersecting Main Street  
 Third Street intersecting Main Street  
 William Street intersecting Second Street  
 William Street intersecting Third Street  
 Steffens Street intersecting First Street  
 Steffens Street intersecting Third Street  
 Ennis Street intersecting First Street  
 Ennis Street intersecting Third Street  
 Hugi Street intersecting First Street  
 Hugi Street intersecting Third Street  
 Fagin Street intersecting First Street  
 Fagin Street intersecting Third Street  
 State Highway No.287 intersecting United States Highway 287

Section 3. That it shall hereafter be unlawful and a violation of this ordinance for any individual driving a motor vehicle within the Town of Ennis to emerge into a street, road or highway within the Town of Ennis from an alley, private driveway or building without stopping said vehicle immediately prior to driving into a sidewalk or sidewalk area and yielding right-of-way to any pedestrian as may be necessary to avoid collision and upon entering the roadway yielding right-of-way to all vehicles approaching on said roadway,

Section 4. Any person violating the provisions of this ordinance shall, upon conviction thereof, be punishable by a fine of not less than five dollars nor more than fifty dollars, provided, however, that if the violation is for entering on to Main Street or a State Highway without stopping the minimum fine shall be ten dollars.
